Damodar Valley Corporation

- The **Damodar Valley Corporation**, popularly known as **DVC**, is the **first multipurpose river valley project** of independent India. The corporation came into being on July 7, 1948 by an Act of the Constituent Assembly of India.
- The initial focus of the DVC were flood control, irrigation, generation, transmission and distribution of electricity, eco-conservation and afforestation, as well as job creation for the socio-economic wellbeing of the people residing in and around areas affected by DVC projects. However, over the past few decades, power generation has gained priority.

Bharat Dynamics Limited

Bharat Dynamics Limited (BDL) is one of India's manufacturer of munitions and missile systems. It was founded in 1970 in Hyderabad, Andhra Pradesh.

BDL specializes in the manufacture of ammunitions, rifles and panels.

Indian Farmers Fertiliser Cooperative Limited (IFFCO)

Established in 1967, **Indian Farmers Fertiliser Cooperative Limited**, also known as **IFFCO**, is the **world's largest fertiliser cooperative federation** based in India which is registered as a Multistate Cooperative Society. IFFCO has 40,000 member cooperatives. The Society is primarily engaged in the production and distribution of fertilisers.
